CHSAA 5A Seeding Process: The top 8 qualifying teams shall be seeded 1-8 based on Wild Card Points. Teams 9-16 shall be seeded based on Wild Card Points, but can be moved to avoid significant geographical conflicts and league match-ups. Teams 17-32 will be paired geographically (avoiding first round league match-ups). Note: Teams can move up or down by 2-3 spots to meet these requirements. **2013 At-Large Teams:** Mountain Vista (114.389), Ralston Vy. (113.895), Smoky Hill (111.105), Fairview (111.053), Ft. Collins (110.895), Cherokee Tr. (109.895), Douglas Co. (109.845). Note: The committee made three adjustments, one to avoid a first round league matchup and two to avoid league matchups in the second round.
